Coupled common fixed point results involving (ϕ, ψ) -contractions in ordered generalized metric spaces with application to integral equations

Abstract

We establish some coupled coincidence and coupled common fixed point theorems for the mixed g -monotone mappings satisfying (ϕ, ψ) -contractive conditions in the setting of ordered generalized metric spaces. Presented theorems extend and generalize the very recent results of Choudhury and Maity (Math. Comput. Model. 54(1-2):73-79, 2011). To illustrate our results, an example and an application to integral equations have also been given.

1 Introduction and preliminaries

Mustafa and Sims [1] introduced the notion of G -metric spaces. The structure of G -metric spaces is a generalization of metric spaces. Mustafa *et al.* [2] initiated the theory of fixed points in G -metric spaces and established the Banach contraction principle in this generalized structure. Afterwards, different authors proved several fixed point results in this space. References [3–17] are some examples of these works.

Definition 1.1 [1] Let X be a nonempty set, and let $G : X \times X \times X \rightarrow R^+$ be a function satisfying the following properties:

(G1) $G(x, y, z) = 0$ if $x = y = z$,

(G2) $0 < G(x, x, y)$ for all $x, y \in X$ with $x \neq y$,

(G3) $G(x, x, y) \leq G(x, y, z)$ for all $x, y, z \in X$ with $z \neq y$,

(G4) $G(x, y, z) = G(x, z, y) = G(y, z, x) = \dots$ (symmetry in all three variables),

(G5) $G(x, y, z) \leq G(x, a, a) + G(a, y, z)$ for all $x, y, z, a \in X$ (rectangle inequality).

Then the function G is called a G -metric on X , and the pair (X, G) is called a G -metric space.

Definition 1.2 [1] Let (X, G) be a G -metric space, and let $\{x_n\}$ be a sequence of points of X . A point $x \in X$ is said to be the limit of the sequence $\{x_n\}$ if $\lim_{n,m \rightarrow \infty} G(x, x_n, x_m) = 0$, and then we say that the sequence $\{x_n\}$ is G -convergent to x .

Thus, if $x_n \rightarrow x$ in G -metric space (X, G) then, for any $\varepsilon > 0$, there exists a positive integer N such that $G(x, x_n, x_m) < \varepsilon$ for all $n, m \geq N$.

In [1], the authors have shown that the G -metric induces a Hausdorff topology, and the convergence described in the definition above is relative to this topology. This topology being Hausdorff, a sequence can converge at most to a point.

Definition 1.3 [1] Let (X, G) be a G -metric space. A sequence $\{x_n\}$ is called a G -Cauchy sequence if for any $\varepsilon > 0$, there is a positive integer N such that $G(x_n, x_m, x_l) < \varepsilon$ for all $n, m, l \geq N$, that is, if $G(x_n, x_m, x_l) \rightarrow 0$, as $n, m, l \rightarrow \infty$.

Lemma 1.4 [1] If (X, G) is a G -metric space, then the following are equivalent:

- (1) $\{x_n\}$ is G -convergent to x ,
- (2) $G(x_n, x_n, x) \rightarrow 0$ as $n \rightarrow \infty$,
- (3) $G(x_n, x, x) \rightarrow 0$ as $n \rightarrow \infty$,
- (4) $G(x_m, x_n, x) \rightarrow 0$ as $m, n \rightarrow \infty$.

Lemma 1.5 [1] If (X, G) is a G -metric space, then the following are equivalent:

- (1) the sequence $\{x_n\}$ is G -Cauchy,
- (2) for every $\varepsilon > 0$, there exists a positive integer N such that $G(x_n, x_m, x_m) < \varepsilon$ for all $n, m \geq N$.

Lemma 1.6 [1] If (X, G) is a G -metric space, then $G(x, y, y) \leq 2G(y, x, x)$ for all $x, y \in X$.

Lemma 1.7 If (X, G) is a G -metric space, then $G(x, x, y) \leq G(x, x, z) + G(z, z, y)$ for all $x, y, z \in X$.

Definition 1.8 [1] Let $(X, G), (X', G')$ be two G -metric spaces. Then a function $f : X \rightarrow X'$ is G -continuous at a point $x \in X$ if and only if it is G -sequentially continuous at x , that is, whenever $\{x_n\}$ is G -convergent to x , $\{f(x_n)\}$ is G' -convergent to $f(x)$.

Lemma 1.9 [1] Let (X, G) be a G -metric space, then the function $G(x, y, z)$ is jointly continuous in all three of its variables.

Definition 1.10 [1] A G -metric space (X, G) is said to be G -complete (or a complete G -metric space) if every G -Cauchy sequence in (X, G) is convergent in X .

Definition 1.11 [10] Let (X, G) be a G -metric space. A mapping $F : X \times X \rightarrow X$ is said to be continuous if for any two G -convergent sequences $\{x_n\}$ and $\{y_n\}$ converging to x and y , respectively, $\{F(x_n, y_n)\}$ is G -convergent to $F(x, y)$.

Recently, fixed point theorems under different contractive conditions in metric spaces endowed with a partial order have been established by various authors. One can see the works noted in the references [7, 10–15, 18–38]. Bhaskar and Lakshmikantham [18] introduced the notion of coupled fixed points and proved some coupled fixed point theorems for a mapping satisfying mixed monotone property. The work [18] was illustrated by proving the existence and uniqueness of the solution for a periodic boundary value problem.

Lakshmikantham and Ćirić [19] extended the notion of mixed monotone property due to Bhaskar and Lakshmikantham [18] by introducing the notion of mixed g -monotone property in partially ordered metric spaces.

Definition 1.12 [18] Let (X, \leq) be a partially ordered set and $F : X \times X \rightarrow X$. The mapping F is said to have the mixed monotone property if $F(x, y)$ is monotone non-decreasing in x and monotone non-increasing in y , that is, for any $x, y \in X$,

$$x_1, x_2 \in X, \quad x_1 \leq x_2 \quad \text{implies} \quad F(x_1, y) \leq F(x_2, y)$$

and

$$y_1, y_2 \in X, \quad y_1 \leq y_2 \quad \text{implies} \quad F(x, y_1) \geq F(x, y_2).$$

Definition 1.13 [19] Let (X, \leq) be a partially ordered set and $F : X \times X \rightarrow X$ and $g : X \rightarrow X$. We say that F has the mixed g -monotone property if F is monotone g -non-decreasing in its first argument and is monotone g -non-increasing in its second argument, that is, for any $x, y \in X$,

$$x_1, x_2 \in X, \quad gx_1 \leq gx_2 \quad \text{implies} \quad F(x_1, y) \leq F(x_2, y)$$

and

$$y_1, y_2 \in X, \quad gy_1 \leq gy_2 \quad \text{implies} \quad F(x, y_1) \geq F(x, y_2).$$

Definition 1.14 [18] An element $(x, y) \in X \times X$ is called a coupled fixed point of the mapping $F : X \times X \rightarrow X$ if $F(x, y) = x$ and $F(y, x) = y$.

Definition 1.15 [19] An element $(x, y) \in X \times X$ is called a coupled coincidence point of the mappings $F : X \times X \rightarrow X$ and $g : X \rightarrow X$ if $F(x, y) = gx$ and $F(y, x) = gy$.

Definition 1.16 [19] An element $(x, y) \in X \times X$ is called a coupled common fixed point of the mappings $F : X \times X \rightarrow X$ and $g : X \rightarrow X$ if $x = gx = F(x, y)$ and $y = gy = F(y, x)$.

Definition 1.17 [19] The mappings $F : X \times X \rightarrow X$ and $g : X \rightarrow X$ are called commutative if

$$gF(x, y) = F(gx, gy)$$

for all $x, y \in X$.

Let (X, \leq) be a partially ordered set and G be a G -metric on X such that (X, G) is a complete G -metric space. Choudhury and Maity [10] established some coupled fixed point theorems for the mixed monotone mapping $F : X \times X \rightarrow X$ under a contractive condition of the form

$$G(F(x, y), F(u, v), F(w, z)) \leq \frac{k}{2} [G(x, u, w) + G(y, v, z)] \tag{1.1}$$

for $x, y, z, u, v, w \in X$ with $x \geq u \geq w$ and $y \leq v \leq z$, where $k \in [0, 1)$.

Different authors extended and generalized the results of Choudhury and Maity [10] under different contractive conditions in G -metric spaces. One can refer to the references [11–15, 17, 31].

Presented work extends and generalizes the work of Choudhury and Maity [10] for a pair commuting mappings. We first prove the existence of coupled coincidence points and then, prove the existence and uniqueness of coupled common fixed points for our main results.

2 Main results

Before we prove our main results, we need the following.

Denote by Φ the class of all functions $\phi : [0, \infty) \rightarrow [0, \infty)$ with the following properties:

- (ϕ_i) ϕ is continuous and non-decreasing;
- (ϕ_{ii}) $\phi(t) = 0$ if $t = 0$;
- (ϕ_{iii}) $\phi(t + s) \leq \phi(t) + \phi(s)$ for all $t, s \in [0, \infty)$.

Denote by Ψ the class of all functions $\psi : [0, \infty) \rightarrow [0, \infty)$ with the following properties:

- (ψ_i) $\lim_{t \rightarrow r} \psi(t) > 0$ for all $r > 0$;
- (ψ_{ii}) $\lim_{t \rightarrow 0^+} \psi(t) = 0$.

Some examples of $\phi(t)$ are kt (where $k > 0$), $\frac{t}{t+1}$, $\frac{t}{t+2}$ and examples of $\psi(t)$ are kt (where $k > 0$), $\frac{\ln(2t+1)}{2}$.

Now, we give our results.

Theorem 2.1 *Let (X, \leq) be a partially ordered set, and suppose that there exists a G -metric G on X such that (X, G) is a complete G -metric space. Let $F : X \times X \rightarrow X$, $g : X \rightarrow X$ be two mappings. Assume that there exist $\phi \in \Phi$ and $\psi \in \Psi$ such that*

$$\begin{aligned} \phi(G(F(x, y), F(u, v), F(w, z))) &\leq \frac{1}{2} \phi(G(gx, gu, gw) + G(gy, gv, gz)) \\ &\quad - \psi\left(\frac{G(gx, gu, gw) + G(gy, gv, gz)}{2}\right) \end{aligned} \tag{2.1}$$

for all $x, y, u, v, w, z \in X$ with $gx \geq gu \geq gw$ and $gy \leq gv \leq gz$.

Assume that F and g satisfy the following conditions:

- (1) $F(X \times X) \subseteq g(X)$,
- (2) F has the mixed g -monotone property,
- (3) F is continuous,
- (4) g is continuous and commutes with F .

Suppose that there exist $x_0, y_0 \in X$ with $gx_0 \leq F(x_0, y_0)$ and $gy_0 \geq F(y_0, x_0)$, then F and g have a coupled coincidence point in X , that is, there exist $x, y \in X$ such that $gx = F(x, y)$ and $gy = F(y, x)$.

Proof Suppose that $x_0, y_0 \in X$ are such that $gx_0 \leq F(x_0, y_0)$, $gy_0 \geq F(y_0, x_0)$. Since $F(X \times X) \subseteq g(X)$, we can choose $x_1, y_1 \in X$ such that $gx_1 = F(x_0, y_0)$, $gy_1 = F(y_0, x_0)$. Again we can choose $x_2, y_2 \in X$ such that $gx_2 = F(x_1, y_1)$, $gy_2 = F(y_1, x_1)$.

Continuing this process, we can construct sequences $\{x_n\}$ and $\{y_n\}$ in X such that

$$gx_{n+1} = F(x_n, y_n), \quad gy_{n+1} = F(y_n, x_n) \quad \text{for all } n \geq 0. \tag{2.2}$$

We shall prove for all $n \geq 0$, that

$$gx_n \leq gx_{n+1}, \tag{2.3}$$

$$gy_n \geq gy_{n+1}. \tag{2.4}$$

Since $gx_0 \leq F(x_0, y_0)$, $gy_0 \geq F(y_0, x_0)$ and $gx_1 = F(x_0, y_0)$, $gy_1 = F(y_0, x_0)$, we have $gx_0 \leq gx_1$, $gy_0 \geq gy_1$, that is, (2.3) and (2.4) hold for $n = 0$.

Suppose that (2.3) and (2.4) hold for some $n > 0$, that is, $gx_n \leq gx_{n+1}$, $gy_n \geq gy_{n+1}$. As F has the mixed g -monotone property, from (2.2), we have

$$gx_{n+1} = F(x_n, y_n) \leq F(x_{n+1}, y_n) \leq F(x_{n+1}, y_{n+1}) = gx_{n+2},$$

and

$$gy_{n+1} = F(y_n, x_n) \geq F(y_{n+1}, x_n) \geq F(y_{n+1}, x_{n+1}) = gy_{n+2}.$$

Then by mathematical induction, it follows that (2.3) and (2.4) hold for all $n \geq 0$.

If for some n , we have $(gx_{n+1}, gy_{n+1}) = (gx_n, gy_n)$, then $gx_{n+1} = F(x_n, y_n) = gx_n$ and $gy_{n+1} = F(y_n, x_n) = gy_n$, that is, F and g have a coincidence point. So now onwards, we suppose that $(gx_{n+1}, gy_{n+1}) \neq (gx_n, gy_n)$ for all $n \geq 0$; that is, we suppose that either $gx_{n+1} = F(x_n, y_n) \neq gx_n$ or $gy_{n+1} = F(y_n, x_n) \neq gy_n$.

Since $gx_n \geq gx_{n-1}$ and $gy_n \leq gy_{n-1}$, from (2.1) and (2.2), we have

$$\begin{aligned} & \phi(G(gx_{n+1}, gx_{n+1}, gx_n)) \\ &= \phi(G(F(x_n, y_n), F(x_n, y_n), F(x_{n-1}, y_{n-1}))) \\ &\leq \frac{1}{2} \phi(G(gx_n, gx_n, gx_{n-1}) + G(gy_n, gy_n, gy_{n-1})) \\ &\quad - \psi \left(\frac{G(gx_n, gx_n, gx_{n-1}) + G(gy_n, gy_n, gy_{n-1})}{2} \right). \end{aligned} \tag{2.5}$$

Similarly, we have

$$\begin{aligned} & \phi(G(gy_{n+1}, gy_{n+1}, gy_n)) \\ &\leq \frac{1}{2} \phi(G(gy_n, gy_n, gy_{n-1}) + G(gx_n, gx_n, gx_{n-1})) \\ &\quad - \psi \left(\frac{G(gy_n, gy_n, gy_{n-1}) + G(gx_n, gx_n, gx_{n-1})}{2} \right). \end{aligned} \tag{2.6}$$

Adding (2.5) and (2.6), we have

$$\begin{aligned} & \phi(G(gx_{n+1}, gx_{n+1}, gx_n)) + \phi(G(gy_{n+1}, gy_{n+1}, gy_n)) \\ &\leq \phi(G(gx_n, gx_n, gx_{n-1}) + G(gy_n, gy_n, gy_{n-1})) \\ &\quad - 2\psi \left(\frac{G(gy_n, gy_n, gy_{n-1}) + G(gx_n, gx_n, gx_{n-1})}{2} \right). \end{aligned} \tag{2.7}$$

By (ϕ_{iii}) , we have

$$\begin{aligned} & \phi(G(gx_{n+1}, gx_{n+1}, gx_n) + G(gy_{n+1}, gy_{n+1}, gy_n)) \\ & \leq \phi(G(gx_{n+1}, gx_{n+1}, gx_n)) + \phi(G(gy_{n+1}, gy_{n+1}, gy_n)). \end{aligned} \tag{2.8}$$

From (2.7) and (2.8), we have

$$\begin{aligned} & \phi(G(gx_{n+1}, gx_{n+1}, gx_n) + G(gy_{n+1}, gy_{n+1}, gy_n)) \\ & \leq \phi(G(gx_n, gx_n, gx_{n-1}) + G(gy_n, gy_n, gy_{n-1})) \\ & \quad - 2\psi\left(\frac{G(gy_n, gy_n, gy_{n-1}) + G(gx_n, gx_n, gx_{n-1})}{2}\right) \end{aligned} \tag{2.9}$$

$$\leq \phi(G(gx_n, gx_n, gx_{n-1}) + G(gy_n, gy_n, gy_{n-1})). \tag{2.10}$$

Using (2.10) and the fact that ϕ is non-decreasing, we get

$$\begin{aligned} & G(gx_{n+1}, gx_{n+1}, gx_n) + G(gy_{n+1}, gy_{n+1}, gy_n) \\ & \leq G(gx_n, gx_n, gx_{n-1}) + G(gy_n, gy_n, gy_{n-1}). \end{aligned}$$

Let $R_n = G(gx_{n+1}, gx_{n+1}, gx_n) + G(gy_{n+1}, gy_{n+1}, gy_n)$, then the sequence $\{R_n\}$ is decreasing. Therefore, there exists some $R \geq 0$ such that

$$\lim_{n \rightarrow \infty} R_n = \lim_{n \rightarrow \infty} [G(gx_{n+1}, gx_{n+1}, gx_n) + G(gy_{n+1}, gy_{n+1}, gy_n)] = R. \tag{2.11}$$

We claim that $R = 0$.

On the contrary, suppose that $R > 0$.

Taking limit as $n \rightarrow \infty$ on both sides of (2.9) and using the properties of ϕ and ψ , we have

$$\begin{aligned} \phi(R) &= \lim_{n \rightarrow \infty} \phi(R_n) \\ &\leq \lim_{n \rightarrow \infty} \left[\phi(R_{n-1}) - 2\psi\left(\frac{R_{n-1}}{2}\right) \right] \\ &= \phi(R) - 2 \lim_{R_{n-1} \rightarrow R} \psi\left(\frac{R_{n-1}}{2}\right) < \phi(R), \quad \text{a contradiction.} \end{aligned}$$

Thus, $R = 0$, that is,

$$\lim_{n \rightarrow \infty} R_n = \lim_{n \rightarrow \infty} [G(gx_{n+1}, gx_{n+1}, gx_n) + G(gy_{n+1}, gy_{n+1}, gy_n)] = 0. \tag{2.12}$$

Next, we shall show that $\{gx_n\}$ and $\{gy_n\}$ are Cauchy sequences.

If possible, suppose that at least one of $\{gx_n\}$ and $\{gy_n\}$ is not a Cauchy sequence. Then there exists an $\varepsilon > 0$, for which we can find subsequences $\{gx_{n(k)}\}$, $\{gx_{m(k)}\}$ of $\{gx_n\}$ and $\{gy_{n(k)}\}$, $\{gy_{m(k)}\}$ of $\{gy_n\}$ with $n(k) > m(k) \geq k$ such that

$$r_k = G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)}) + G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)}) \geq \varepsilon. \tag{2.13}$$

Further, corresponding to $m(k)$, we can choose $n(k)$ in such a way that it is the smallest integer with $n(k) > m(k) \geq k$ and satisfies (2.13). Then

$$G(gx_{n(k)-1}, gx_{n(k)-1}, gx_{m(k)}) + G(gy_{n(k)-1}, gy_{n(k)-1}, gy_{m(k)}) < \varepsilon. \tag{2.14}$$

By (2.13), (2.14) and (G5), we have

$$\begin{aligned} \varepsilon \leq r_k &= G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)}) + G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)}) \\ &\leq G(gx_{n(k)}, gx_{n(k)}, gx_{n(k)-1}) + G(gx_{n(k)-1}, gx_{n(k)-1}, gx_{m(k)}) \\ &\quad + G(gy_{n(k)}, gy_{n(k)}, gy_{n(k)-1}) + G(gy_{n(k)-1}, gy_{n(k)-1}, gy_{m(k)}) \\ &< G(gx_{n(k)}, gx_{n(k)}, gx_{n(k)-1}) + G(gy_{n(k)}, gy_{n(k)}, gy_{n(k)-1}) + \varepsilon. \end{aligned} \tag{2.15}$$

Letting $k \rightarrow \infty$ in (2.15) and using (2.12), we have

$$\lim_{n \rightarrow \infty} r_k = \lim_{n \rightarrow \infty} [G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)}) + G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)})] = \varepsilon. \tag{2.16}$$

Again by (G5) and Lemma 1.6, we have

$$\begin{aligned} &G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)}) \\ &\leq G(gx_{n(k)}, gx_{n(k)}, gx_{n(k)+1}) + G(gx_{n(k)+1}, gx_{n(k)+1}, gx_{m(k)}) \\ &\leq 2G(gx_{n(k)+1}, gx_{n(k)+1}, gx_{n(k)}) \\ &\quad + G(gx_{n(k)+1}, gx_{n(k)+1}, gx_{m(k)+1}) + G(gx_{m(k)+1}, gx_{m(k)+1}, gx_{m(k)}). \end{aligned} \tag{2.17}$$

Similarly, we have

$$\begin{aligned} &G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)}) \\ &\leq 2G(gy_{n(k)+1}, gy_{n(k)+1}, gy_{n(k)}) \\ &\quad + G(gy_{n(k)+1}, gy_{n(k)+1}, gy_{m(k)+1}) + G(gy_{m(k)+1}, gy_{m(k)+1}, gy_{m(k)}). \end{aligned} \tag{2.18}$$

Summing (2.17) and (2.18), we have

$$\begin{aligned} r_k &= G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)}) + G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)}) \\ &\leq 2R_{n(k)} + R_{m(k)} + G(gx_{n(k)+1}, gx_{n(k)+1}, gx_{m(k)+1}) + G(gy_{n(k)+1}, gy_{n(k)+1}, gy_{m(k)+1}). \end{aligned}$$

Since ϕ is non-decreasing and by (ϕ_{iii}) , we have

$$\begin{aligned} \phi(r_k) &\leq \phi(2R_{n(k)} + R_{m(k)} + G(gx_{n(k)+1}, gx_{n(k)+1}, gx_{m(k)+1}) \\ &\quad + G(gy_{n(k)+1}, gy_{n(k)+1}, gy_{m(k)+1})) \\ &\leq 2\phi(R_{n(k)}) + \phi(R_{m(k)}) \\ &\quad + \phi(G(gx_{n(k)+1}, gx_{n(k)+1}, gx_{m(k)+1})) + \phi(G(gy_{n(k)+1}, gy_{n(k)+1}, gy_{m(k)+1})). \end{aligned} \tag{2.19}$$

Since $n(k) > m(k)$, $gx_{n(k)} \geq gx_{m(k)}$ and $gy_{n(k)} \leq gy_{m(k)}$, then from (2.1) and (2.2), we have

$$\begin{aligned} & \phi(G(gx_{n(k)+1}, gx_{n(k)+1}, gx_{m(k)+1})) \\ &= \phi(G(F(x_{n(k)}, y_{n(k)}), F(x_{n(k)}, y_{n(k)}), F(x_{m(k)}, y_{m(k)}))) \\ &\leq \frac{1}{2} \phi(G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)}) + G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)})) \\ &\quad - \psi\left(\frac{G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)}) + G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)})}{2}\right) \\ &= \frac{1}{2} \phi(r_k) - \psi\left(\frac{r_k}{2}\right). \end{aligned} \tag{2.20}$$

Similarly, we have

$$\begin{aligned} & \phi(G(gy_{n(k)+1}, gy_{n(k)+1}, gy_{m(k)+1})) \\ &\leq \frac{1}{2} \phi(G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)}) + G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)})) \\ &\quad - \psi\left(\frac{G(gy_{n(k)}, gy_{n(k)}, gy_{m(k)}) + G(gx_{n(k)}, gx_{n(k)}, gx_{m(k)})}{2}\right) \\ &= \frac{1}{2} \phi(r_k) - \psi\left(\frac{r_k}{2}\right). \end{aligned} \tag{2.21}$$

Using (2.19)-(2.21), we have

$$\phi(r_k) \leq 2\phi(R_{n(k)}) + \phi(R_{m(k)}) + \phi(r_k) - 2\psi\left(\frac{r_k}{2}\right).$$

Letting $k \rightarrow \infty$ in the last inequality, and using (2.12), (2.16) and the properties of ϕ and ψ , we have

$$\begin{aligned} \phi(\varepsilon) &\leq 2\phi(0) + \phi(0) + \phi(\varepsilon) - 2 \lim_{k \rightarrow \infty} \psi\left(\frac{r_k}{2}\right) \\ &= \phi(\varepsilon) - 2 \lim_{rk \rightarrow \varepsilon} \psi\left(\frac{r_k}{2}\right) < \phi(\varepsilon), \quad \text{a contradiction.} \end{aligned}$$

Therefore, both $\{gx_n\}$ and $\{gy_n\}$ are Cauchy sequences in X . Now, since the space (X, G) is a complete G -metric space, there exist x, y in X such that the sequences $\{gx_n\}$ and $\{gy_n\}$ are respectively G -convergent to x and y , then, using Lemma 1.4, we have

$$\lim_{n \rightarrow \infty} G(gx_n, gx_n, x) = \lim_{n \rightarrow \infty} G(gx_n, x, x) = 0, \tag{2.22}$$

$$\lim_{n \rightarrow \infty} G(gy_n, gy_n, y) = \lim_{n \rightarrow \infty} G(gy_n, y, y) = 0. \tag{2.23}$$

Using the G -continuity of g , Definition 1.8 and Lemma 1.4, we have

$$\lim_{n \rightarrow \infty} G(ggx_n, ggx_n, gx) = \lim_{n \rightarrow \infty} G(ggx_n, gx, gx) = 0, \tag{2.24}$$

$$\lim_{n \rightarrow \infty} G(ggy_n, ggy_n, gy) = \lim_{n \rightarrow \infty} G(ggy_n, gy, gy) = 0. \tag{2.25}$$

Since $gx_{n+1} = F(x_n, y_n)$ and $gy_{n+1} = F(y_n, x_n)$, hence the commutativity of F and g implies that

$$ggx_{n+1} = gF(x_n, y_n) = F(gx_n, gy_n), \tag{2.26}$$

$$ggy_{n+1} = gF(y_n, x_n) = F(gy_n, gx_n). \tag{2.27}$$

Since the mapping F is G -continuous, and the sequences $\{gx_n\}$ and $\{gy_n\}$ are respectively G -convergent to x and y , hence using Definition 1.11, the sequence $\{F(gx_n, gy_n)\}$ is G -convergent to $F(x, y)$. Then, by uniqueness of the limit, and using (2.24), (2.26), we finally get $F(x, y) = gx$. Similarly, we can show that $F(y, x) = gy$. Hence (x, y) is a coupled coincidence point of F and g . \square

Taking g to be an identity mapping in Theorem 2.1, we have the following corollary.

Corollary 2.1 *Let (X, \leq) be a partially ordered set, and suppose that there exists a G -metric G on X such that (X, G) is a complete G -metric space. Let $F : X \times X \rightarrow X$ be a mapping. Assume that there exist $\phi \in \Phi$ and $\psi \in \Psi$ such that*

$$\begin{aligned} \phi(G(F(x, y), F(u, v), F(w, z))) &\leq \frac{1}{2}\phi(G(x, u, w) + G(y, v, z)) \\ &\quad - \psi\left(\frac{G(x, u, w) + G(y, v, z)}{2}\right) \end{aligned} \tag{2.28}$$

for all $x, y, u, v, w, z \in X$ with $x \geq u \geq w$ and $y \leq v \leq z$.

Assume that F satisfies the following conditions:

- (1) F has the mixed monotone property,
- (2) F is continuous.

Suppose that there exist $x_0, y_0 \in X$ with $x_0 \leq F(x_0, y_0)$ and $y_0 \geq F(y_0, x_0)$, then there exist $x, y \in X$ such that $x = F(x, y)$ and $y = F(y, x)$.

Taking ϕ and g to be identity mappings in Theorem 2.1, we have the following corollary.

Corollary 2.2 *Let (X, \leq) be a partially ordered set, and suppose that there exists a G -metric G on X such that (X, G) is a complete G -metric space. Let $F : X \times X \rightarrow X$ be a mapping. Assume there exists $\psi \in \Psi$ such that*

$$\begin{aligned} G(F(x, y), F(u, v), F(w, z)) &\leq \frac{1}{2}(G(x, u, w) + G(y, v, z)) \\ &\quad - \psi\left(\frac{G(x, u, w) + G(y, v, z)}{2}\right) \end{aligned} \tag{2.29}$$

for all $x, y, u, v, w, z \in X$ with $x \geq u \geq w$ and $y \leq v \leq z$.

Assume that F satisfies the following conditions:

- (1) F has the mixed monotone property,
- (2) F is continuous.

Suppose there exist $x_0, y_0 \in X$ with $x_0 \leq F(x_0, y_0)$ and $y_0 \geq F(y_0, x_0)$, then there exist $x, y \in X$ such that $x = F(x, y)$ and $y = F(y, x)$.

Taking ϕ to be an identity mapping and $\psi(t) = (1 - k)t$, $0 \leq k < 1$ in Theorem 2.1, we have the following result.

Corollary 2.3 *Let (X, \leq) be a partially ordered set and suppose there exists a G -metric G on X such that (X, G) is a complete G -metric space. Let $F : X \times X \rightarrow X$, $g : X \rightarrow X$ be two mappings. Assume there exists a real number $k \in [0, 1)$ such that*

$$G(F(x, y), F(u, v), F(w, z)) \leq \frac{k}{2} [G(gx, gu, gw) + G(gy, gv, gz)] \tag{2.30}$$

for all x, y, u, v, w, z in X with $gx \geq gu \geq gw$, $gy \leq gv \leq gz$.

Assume that F and g satisfy the following conditions:

- (1) $F(X \times X) \subseteq g(X)$,
- (2) F has the mixed g -monotone property,
- (3) F is continuous,
- (4) g is continuous and commutes with F .

Suppose that there exist $x_0, y_0 \in X$ with $gx_0 \leq F(x_0, y_0)$ and $gy_0 \geq F(y_0, x_0)$, then F and g have a coupled coincidence point in X , that is, there exist $x, y \in X$ such that $gx = F(x, y)$ and $gy = F(y, x)$.

Remark 2.1 Corollary 2.3 is an extension of Theorem 3.1 of Choudhury and Maity [10] for a pair of commuting mappings. Further, taking g to be the identity mapping in Corollary 2.3, we obtain Theorem 3.1 of Choudhury and Maity [10].

In the next theorem, we omit the continuity hypotheses of F . We need the following definition.

Definition 2.1 Let (X, \leq) be a partially ordered set and suppose there exists a G -metric G on X . We say that (X, G, \leq) is regular if the following conditions hold:

- (i) if a non-decreasing sequence $\{x_n\}$ is such that $x_n \rightarrow x$, then $x_n \leq x$ for all n ,
- (ii) if a non-increasing sequence $\{y_n\}$ is such that $y_n \rightarrow y$, then $y \leq y_n$ for all n .

Theorem 2.2 *Let (X, \leq) be a partially ordered set, and suppose there exists a G -metric G on X . Let $F : X \times X \rightarrow X$, $g : X \rightarrow X$ be two mappings. Assume there exist $\phi \in \Phi$ and $\psi \in \Psi$ such that*

$$\begin{aligned} \phi(G(F(x, y), F(u, v), F(w, z))) &\leq \frac{1}{2} \phi(G(gx, gu, gw) + G(gy, gv, gz)) \\ &\quad - \psi\left(\frac{G(gx, gu, gw) + G(gy, gv, gz)}{2}\right) \end{aligned} \tag{2.31}$$

for all $x, y, u, v, w, z \in X$ with $gx \geq gu \geq gw$ and $gy \leq gv \leq gz$.

Assume that (X, G, \leq) is regular. Suppose that $(g(X), G)$ is G -complete, F has the mixed g -monotone property and $F(X \times X) \subseteq g(X)$. Suppose that there exist $x_0, y_0 \in X$ with $gx_0 \leq F(x_0, y_0)$ and $gy_0 \geq F(y_0, x_0)$, then F and g have a coupled coincidence point in X , that is, there exist $x, y \in X$ such that $gx = F(x, y)$ and $gy = F(y, x)$.

Proof Proceeding exactly as in Theorem 2.1, we have that $\{gx_n\}$ and $\{gy_n\}$ are G -Cauchy sequences in the G -complete G -metric space $(g(X), G)$. Then there exist $x, y \in X$ such that

$gx_n \rightarrow gx$ and $gy_n \rightarrow gy$, that is,

$$\begin{aligned} \lim_{n \rightarrow \infty} G(gx_n, gx, gx) &= \lim_{n \rightarrow \infty} G(gx_n, gx_n, gx) = 0, \\ \lim_{n \rightarrow \infty} G(gy_n, gy, gy) &= \lim_{n \rightarrow \infty} G(gy_n, gy_n, gy) = 0. \end{aligned} \tag{2.32}$$

Since $\{gx_n\}$ is non-decreasing and $\{gy_n\}$ is non-increasing, using the regularity of (X, G, \leq) , we have $gx_n \leq gx$ and $gy \leq gy_n$ for all $n \geq 0$. Using (2.31), we get

$$\begin{aligned} \phi(G(F(x, y), gx_{n+1}, gx_{n+1})) &= \phi(G(F(x, y), F(x_n, y_n), F(x_n, y_n))) \\ &\leq \frac{1}{2} \phi(G(gx, gx_n, gx_n) + G(gy, gy_n, gy_n)) \\ &\quad - \psi \left(\frac{G(gx, gx_n, gx_n) + G(gy, gy_n, gy_n)}{2} \right). \end{aligned} \tag{2.33}$$

Letting $n \rightarrow \infty$ in (2.33), then using (2.32) and the properties of ϕ and ψ , we obtain that

$$\begin{aligned} \phi \left(\lim_{n \rightarrow \infty} G(F(x, y), gx_{n+1}, gx_{n+1}) \right) &\leq \frac{1}{2} \phi \left(\lim_{n \rightarrow \infty} (G(gx, gx_n, gx_n) + G(gy, gy_n, gy_n)) \right) \\ &\quad - \lim_{n \rightarrow \infty} \psi \left(\frac{G(gx, gx_n, gx_n) + G(gy, gy_n, gy_n)}{2} \right) \\ &= 0, \end{aligned}$$

which gives us

$$\lim_{n \rightarrow \infty} G(F(x, y), gx_{n+1}, gx_{n+1}) = 0. \tag{2.34}$$

On the other hand, by condition (G5) we have

$$G(F(x, y), gx, gx) \leq G(F(x, y), gx_{n+1}, gx_{n+1}) + G(gx_n, gx, gx).$$

Letting $n \rightarrow \infty$, using (2.32) and (2.34), we have $G(F(x, y), gx, gx) = 0$. So $F(x, y) = gx$.

Similarly, we can obtain that $gy = F(y, x)$. Thus, we proved that (x, y) is a coupled coincidence point of F and g . \square

Taking ϕ to be the identity mapping and $\psi(t) = (1 - k)t$, $0 \leq k < 1$ in Theorem 2.2, we have the following result.

Corollary 2.4 *Let (X, \leq) be a partially ordered set, and suppose that there exists a G-metric G on X . Let $F : X \times X \rightarrow X$, $g : X \rightarrow X$ be two mappings. Assume that there exists a real number $k \in [0, 1)$ such that*

$$G(F(x, y), F(u, v), F(w, z)) \leq \frac{k}{2} [G(gx, gu, gw) + G(gy, gv, gz)] \tag{2.35}$$

for all x, y, u, v, w, z in X with $gx \geq gu \geq gw, gy \leq gv \leq gz$.

Assume that (X, G, \leq) is regular. Suppose that $(g(X), G)$ is G -complete, F has the mixed g -monotone property and $F(X \times X) \subseteq g(X)$. Also, assume that there exist $x_0, y_0 \in X$ with

$gx_0 \leq F(x_0, y_0)$ and $gy_0 \geq F(y_0, x_0)$, then F and g have a coupled coincidence point in X , that is, there exist $x, y \in X$ such that $gx = F(x, y)$ and $gy = F(y, x)$.

Remark 2.2 Corollary 2.4 is an extension of the Theorem 3.2 of Choudhury and Maity [10] for a pair of commuting mappings. Further, taking g to be the identity mapping in Corollary 2.4, we can obtain Theorem 3.2 of Choudhury and Maity [10].

Taking ϕ and g to be identity mappings in Theorem 2.2, we have the following result.

Corollary 2.5 Let (X, \leq) be a partially ordered set, and suppose that there is a G -metric G on X such that (X, G) is a complete metric space. Let $F : X \times X \rightarrow X$ be a mapping having mixed a monotone property. Assume that there exists $\psi \in \Psi$ such that

$$G(F(x, y), F(u, v), F(w, z)) \leq \frac{1}{2}(G(x, u, w) + G(y, v, z)) - \psi\left(\frac{G(x, u, w) + G(y, v, z)}{2}\right) \tag{2.36}$$

for all $x, y, u, v, w, z \in X$ with $x \geq u \geq w$ and $y \leq v \leq z$.

Assume that (X, G, \leq) is regular. Suppose that there exist $x_0, y_0 \in X$ with $x_0 \leq F(x_0, y_0)$ and $y_0 \geq F(y_0, x_0)$, then there exist $x, y \in X$ such that $x = F(x, y)$ and $y = F(y, x)$.

Next, we give an example in support of Theorem 2.2.

Example 2.1 Let $X = [0, 1]$. Then (X, \leq) is a partially ordered set with the natural ordering of real numbers. Let $G : X \times X \times X \rightarrow R^+$ be defined by

$$G(x, y, z) = |x - y| + |y - z| + |z - x| \quad \text{for } x, y, z \in X.$$

Then (X, G) is a regular G -metric space.

Let $g : X \rightarrow X$ be defined as

$$g(x) = \frac{x}{2} \quad \text{for all } x \in X.$$

Let $F : X \times X \rightarrow X$ be defined as

$$F(x, y) = \begin{cases} \frac{x-y}{24}, & \text{if } x, y \in [0, 1], x \geq y, \\ 0, & \text{if } x < y. \end{cases}$$

Clearly, F obeys the mixed g -monotone property. Also, $F(X \times X) \subseteq g(X)$ and $(g(X), G)$ is complete.

Let $\phi, \psi : [0, \infty) \rightarrow [0, \infty)$ be defined by $\phi(t) = \frac{t}{2}, \psi(t) = \frac{t}{4}$ for $t \in [0, \infty)$.

Also, $x_0 = 0$ and $y_0 = c (> 0)$ are two points in X such that $g(x_0) = g(0) = 0 = F(0, c) = F(x_0, y_0)$ and $g(y_0) = g(c) = \frac{c}{2} \geq \frac{c}{24} = F(c, 0) = F(y_0, x_0)$.

Next, we verify inequality (2.31) of Theorem 2.2.

We take $x, y, u, v, w, z \in X$ such that $gx \geq gu \geq gw$ and $gy \leq gv \leq gz$; that is, $x \geq u \geq w$ and $y \leq v \leq z$. We discuss the following cases.

Case 1: $x \geq y, u \geq v, w \geq z$.

Then

$$\begin{aligned}
 & \phi(G(F(x, y), F(u, v), F(w, z))) \\
 &= \phi\left(G\left(\frac{x-y}{24}, \frac{u-v}{24}, \frac{w-z}{24}\right)\right) \\
 &= \frac{1}{2} \left\{ \frac{|(x-y) - (u-v)|}{24} + \frac{|(u-v) - (w-z)|}{24} + \frac{|(w-z) - (x-y)|}{24} \right\} \\
 &= \frac{1}{48} \{ |(x-u) - (y-v)| + |(u-w) - (v-z)| + |(w-x) - (z-y)| \} \\
 &\leq \frac{1}{48} \{ (x-u) + (v-y) + (u-w) + (z-v) + (x-w) + (z-y) \} \\
 &= \frac{1}{24} \left\{ \left(\frac{(x-u)}{2} + \frac{(u-w)}{2} + \frac{(x-w)}{2} \right) + \left(\frac{(v-y)}{2} + \frac{(z-v)}{2} + \frac{(z-y)}{2} \right) \right\} \\
 &= \frac{1}{24} \{ G(gx, gu, gw) + G(gy, gv, gz) \} \\
 &\leq \frac{1}{8} \{ G(gx, gu, gw) + G(gy, gv, gz) \} \\
 &= \frac{1}{2} \phi(G(gx, gu, gw) + G(gy, gv, gz)) - \psi\left(\frac{G(gx, gu, gw) + G(gy, gv, gz)}{2}\right).
 \end{aligned}$$

Case 2: $x \geq y, u \geq v, w < z$.

Then

$$\begin{aligned}
 & \phi(G(F(x, y), F(u, v), F(w, z))) \\
 &= \phi\left(G\left(\frac{x-y}{24}, \frac{u-v}{24}, 0\right)\right) \\
 &= \frac{1}{2} \left\{ \frac{|(x-y) - (u-v)|}{24} + \frac{|(u-v)|}{24} + \frac{|(x-y)|}{24} \right\} \\
 &= \frac{1}{48} \{ |(x-u) - (y-v)| + |(u-v)| + |(x-y)| \} \\
 &\leq \frac{1}{48} \{ (x-u) + (v-y) + (u-v) + (x-y) \} \\
 &= \frac{1}{48} \{ (x-u) + (v-y) + (u-w + w-v) + (x-w + w-y) \} \\
 &= \frac{1}{48} \{ (x-u) + (v-y) + (u-w) + (w-v) + (x-w) + (w-y) \} \\
 &\leq \frac{1}{48} \{ (x-u) + (v-y) + (u-w) + (z-v) + (x-w) + (z-y) \} \\
 &= \frac{1}{24} \left\{ \left(\frac{(x-u)}{2} + \frac{(u-w)}{2} + \frac{(x-w)}{2} \right) + \left(\frac{(v-y)}{2} + \frac{(z-v)}{2} + \frac{(z-y)}{2} \right) \right\} \\
 &= \frac{1}{24} \{ G(gx, gu, gw) + G(gy, gv, gz) \} \\
 &\leq \frac{1}{8} \{ G(gx, gu, gw) + G(gy, gv, gz) \}
 \end{aligned}$$

$$\begin{aligned}
 &= \frac{1}{2} \phi(G(gx, gu, gw) + G(gy, gv, gz)) \\
 &\quad - \psi\left(\frac{G(gx, gu, gw) + G(gy, gv, gz)}{2}\right).
 \end{aligned}$$

Case 3: $x \geq y, u < v, w < z$.

Then

$$\begin{aligned}
 &\phi(G(F(x, y), F(u, v), F(w, z))) \\
 &= \phi\left(G\left(\frac{x-y}{24}, 0, 0\right)\right) \\
 &= \frac{1}{2} \left\{ \frac{|(x-y)|}{24} + \frac{|(x-y)|}{24} \right\} = \frac{1}{2} \left\{ \frac{(x-y)}{24} + \frac{(x-y)}{24} \right\} \\
 &= \frac{1}{48} \{(x-u + u-y) + (x-w + w-y)\} \\
 &= \frac{1}{48} \{(x-u) + (u-y) + (x-w) + (w-y)\} \\
 &\leq \frac{1}{48} \{(x-u) + (v-y) + (x-w) + (w-u + u-y)\} \\
 &= \frac{1}{48} \{(x-u) + (v-y) + (x-w) + (w-u) + (u-y)\} \\
 &= \frac{1}{48} \{(x-u) + (v-y) + (x-w) + (w-u) + (u-z + z-y)\} \\
 &\leq \frac{1}{48} \{(x-u) + (v-y) + (x-w) + (u-w) + (v-z) + (z-y)\} \\
 &= \frac{1}{24} \left\{ \left(\frac{(x-u)}{2} + \frac{(u-w)}{2} + \frac{(x-w)}{2} \right) + \left(\frac{(v-y)}{2} + \frac{(z-v)}{2} + \frac{(z-y)}{2} \right) \right\} \\
 &= \frac{1}{24} \{G(gx, gu, gw) + G(gy, gv, gz)\} \\
 &\leq \frac{1}{8} \{G(gx, gu, gw) + G(gy, gv, gz)\} \\
 &= \frac{1}{2} \phi(G(gx, gu, gw) + G(gy, gv, gz)) - \psi\left(\frac{G(gx, gu, gw) + G(gy, gv, gz)}{2}\right).
 \end{aligned}$$

Case 4: $x < y, u < v, w < z$.

Then $\phi(G(F(x, y), F(u, v), F(w, z))) = \phi(0) = 0$, and hence inequality (2.31) of Theorem 2.2 is obvious.

Similarly, the cases like $x < y, u \geq v, w \geq z; x < y, u < v, w \geq z$ and others follow immediately.

Thus, it is verified that the functions F, g, ϕ, ψ satisfy all the conditions of Theorem 2.2. Indeed, $(0, 0)$ is the coupled coincidence point of F and g in X .

Next, we prove the existence and uniqueness of the coupled common fixed point for our main result.

Theorem 2.3 *In addition to the hypotheses of Theorem 2.1, suppose that for every $(x, y), (x^*, y^*) \in X \times X$ there exists a $(u, v) \in X \times X$ such that $(F(u, v), F(v, u))$ is comparable*

to $(F(x, y), F(y, x))$ and $(F(x^*, y^*), F(y^*, x^*))$. Then F and g have a unique coupled common fixed point, that is, there exists a unique $(a, b) \in X \times X$ such that $a = g(a) = F(a, b)$ and $b = g(b) = F(b, a)$.

Proof From Theorem 2.1, the set of coupled coincidences is non-empty. In order to prove the theorem, we shall first show that if (x, y) and (x^*, y^*) are coupled coincidence points, that is, if $gx = F(x, y)$, $gy = F(y, x)$ and $gx^* = F(x^*, y^*)$, $gy^* = F(y^*, x^*)$, then

$$gx = gx^* \quad \text{and} \quad gy = gy^*. \tag{2.37}$$

By assumption, there is $(u, v) \in X \times X$ such that $(F(u, v), F(v, u))$ is comparable with $(F(x, y), F(y, x))$ and $(F(x^*, y^*), F(y^*, x^*))$. Put $u_0 = u$, $v_0 = v$ and choose $u_1, v_1 \in X$ so that $gu_1 = F(u_0, v_0)$, $gv_1 = F(v_0, u_0)$.

Then, similarly as in the proof of Theorem 2.1, we can inductively define sequences $\{gu_n\}$ and $\{gv_n\}$ such that $gu_{n+1} = F(u_n, v_n)$ and $gv_{n+1} = F(v_n, u_n)$.

Further, set $x_0 = x$, $y_0 = y$, $x_0^* = x^*$, $y_0^* = y^*$ and, on the same way, define the sequences $\{gx_n\}$, $\{gy_n\}$ and $\{gx_n^*\}$, $\{gy_n^*\}$. Then it is easy to show that

$$\begin{aligned} gx_{n+1} &= F(x_n, y_n), & gy_{n+1} &= F(y_n, x_n) \quad \text{and} \\ gx_{n+1}^* &= F(x_n^*, y_n^*), & gy_{n+1}^* &= F(y_n^*, x_n^*) \quad \text{for all } n \geq 0. \end{aligned}$$

Since $(F(x, y), F(y, x)) = (gx_1, gy_1) = (gx, gy)$ and $(F(u, v), F(v, u)) = (gu_1, gv_1)$ are comparable, then $gu_1 \geq gx$ and $gv_1 \leq gy$. It is easy to show that (gx, gy) and (gu_n, gv_n) are comparable, that is, $gu_n \geq gx$ and $gv_n \leq gy$ for all $n \geq 1$. Thus, from (2.1)

$$\begin{aligned} \phi(G(gu_{n+1}, gu_{n+1}, gx)) &= \phi(G(F(u_n, v_n), F(u_n, v_n), F(x, y))) \\ &\leq \frac{1}{2} \phi(G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)) \\ &\quad - \psi \left(\frac{G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)}{2} \right), \end{aligned} \tag{2.38}$$

and

$$\begin{aligned} \phi(G(gv_{n+1}, gv_{n+1}, gy)) &\leq \frac{1}{2} \phi(G(gv_n, gv_n, gy) + G(gu_n, gu_n, gx)) \\ &\quad - \psi \left(\frac{G(gv_n, gv_n, gy) + G(gu_n, gu_n, gx)}{2} \right). \end{aligned} \tag{2.39}$$

Adding (2.38) and (2.39), we get

$$\begin{aligned} &\phi(G(gu_{n+1}, gu_{n+1}, gx)) + \phi(G(gv_{n+1}, gv_{n+1}, gy)) \\ &\leq \phi(G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)) \\ &\quad - 2\psi \left(\frac{G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)}{2} \right). \end{aligned} \tag{2.40}$$

Also, by (ϕ_{iii}) we have

$$\begin{aligned} & \phi(G(gu_{n+1}, gu_{n+1}, gx) + G(gv_{n+1}, gv_{n+1}, gy)) \\ & \leq \phi(G(gu_{n+1}, gu_{n+1}, gx)) + \phi(G(gv_{n+1}, gv_{n+1}, gy)). \end{aligned} \tag{2.41}$$

From (2.40) and (2.41),

$$\begin{aligned} & \phi(G(gu_{n+1}, gu_{n+1}, gx) + G(gv_{n+1}, gv_{n+1}, gy)) \\ & \leq \phi(G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)) \\ & \quad - 2\psi\left(\frac{G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)}{2}\right) \end{aligned} \tag{2.42}$$

$$\leq \phi(G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)). \tag{2.43}$$

Since ϕ is non-decreasing, from (2.43), it follows that

$$G(gu_{n+1}, gu_{n+1}, gx) + G(gv_{n+1}, gv_{n+1}, gy) \leq G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy).$$

Let $\alpha_n = G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)$, then $\{\alpha_n\}$ is a monotonic decreasing sequence, so there exists some $\alpha \geq 0$ such that $\lim_{n \rightarrow \infty} \alpha_n = \alpha$.

We shall show that $\alpha = 0$. Suppose, on the contrary, that $\alpha > 0$. Then taking limit as $n \rightarrow \infty$, in (2.42) and using the continuity of ϕ and the property (ψ_i) , we have

$$\phi(\alpha) \leq \phi(\alpha) - 2 \lim_{\alpha_n \rightarrow \alpha} \psi\left(\frac{\alpha_n}{2}\right) < \phi(\alpha).$$

A contradiction. Thus, $\alpha = 0$, that is,

$$\lim_{n \rightarrow \infty} \alpha_n = \lim_{n \rightarrow \infty} (G(gu_n, gu_n, gx) + G(gv_n, gv_n, gy)) = 0.$$

Hence, it follows that $gu_n \rightarrow gx$, $gv_n \rightarrow gy$.

Similarly, one can show that $gu_n \rightarrow gx^*$, $gv_n \rightarrow gy^*$.

By uniqueness of limit, it follows that $gx = gx^*$ and $gy = gy^*$. Thus, we have proved (2.37).

Since $gx = F(x, y)$, $gy = F(y, x)$ and the pair (F, g) is commuting, it follows that

$$ggx = gF(x, y) = F(gx, gy) \quad \text{and} \quad ggy = gF(y, x) = F(gy, gx). \tag{2.44}$$

Denote $gx = z$, $gy = w$. Then from (2.44), we have

$$gz = F(z, w) \quad \text{and} \quad gw = F(w, z). \tag{2.45}$$

Thus, (z, w) is a coupled coincidence point.

Then from (2.37) with $x^* = z$ and $y^* = w$, it follows that $gz = gx$ and $gw = gy$, that is,

$$gz = z, \quad gw = w. \tag{2.46}$$

From (2.45) and (2.46), we have

$$z = gz = F(z, w) \quad \text{and} \quad w = gw = F(w, z).$$

Therefore, (z, w) is the coupled common fixed point of F and g .

To prove the uniqueness, assume that (p, q) is another coupled common fixed point. Then by (2.37), we have $p = gp = gz = z$ and $q = gq = gw = w$. □

Theorem 2.4 *Under the hypotheses of Theorem 2.2, suppose, in addition, that for every (x, y) and (x^*, y^*) in X , there exists $(u, v) \in X \times X$ such that $(F(u, v), F(v, u))$ is comparable to $(F(x, y), F(y, x))$ and $(F(x^*, y^*), F(y^*, x^*))$. If F and g are commuting, then F and g have a unique coupled common fixed point, that is, there exists a unique $(a, b) \in X \times X$ such that $a = g(a) = F(a, b)$ and $b = g(b) = F(b, a)$.*

Proof Following the steps of Theorem 2.3, proof follows immediately. □

3 Application to integral equations

Motivated by the work of Aydi *et al.* [15], in this section, we study the existence of solutions to nonlinear integral equations using some of our main results.

Consider the integral equations in the following system:

$$\begin{aligned} x(t) &= p(t) + \int_0^T S(t, s)[f(s, x(s)) + k(s, y(s))] ds, \\ y(t) &= p(t) + \int_0^T S(t, s)[f(s, y(s)) + k(s, x(s))] ds. \end{aligned} \tag{3.1}$$

As defined by Luong *et al.* [31], let Θ denote the class of those functions $\theta : [0, \infty) \rightarrow [0, \infty)$, which satisfy the following conditions:

- (I) θ is increasing;
- (II) There exists $\psi \in \Psi$ such that $\theta(r) = \frac{r}{2} - \psi(\frac{r}{2})$, for all $r \in [0, \infty)$.
 For example, $\theta_1(x) = \alpha x$, where $0 \leq \alpha \leq \frac{1}{2}$, $\theta_2(x) = \frac{x^2}{2(x+1)}$ are some members of Θ .

We shall analyze the system (3.1) under the following assumptions:

- (i) $f, k : [0, T] \times \mathbb{R} \rightarrow \mathbb{R}$ are continuous,
- (ii) $p : [0, T] \rightarrow \mathbb{R}$ is continuous,
- (iii) $S : [0, T] \times \mathbb{R} \rightarrow [0, \infty)$ is continuous,
- (iv) there exists $\lambda > 0$ and $\theta \in \Theta$ such that for all $x, y \in \mathbb{R}, y \geq x$,

$$0 \leq f(s, y) - f(s, x) \leq \lambda \theta(y - x),$$

$$0 \leq k(s, x) - k(s, y) \leq \lambda \theta(y - x).$$

- (v) We suppose that

$$3\lambda \sup_{t \in [0, T]} \int_0^T S(t, s) ds \leq \frac{1}{2}.$$

(vi) There exist continuous functions $\alpha, \beta : [0, T] \rightarrow \mathbb{R}$ such that

$$\alpha(t) \leq p(t) + \int_a^b S(t, s)(f(s, \alpha(s)) + k(s, \beta(s))) ds,$$

$$\beta(t) \geq p(t) + \int_a^b S(t, s)(f(s, \beta(s)) + k(s, \alpha(s))) ds.$$

Consider the space $X = C([0, T], \mathbb{R})$ of continuous functions defined on $[0, T]$ endowed with the (G -complete) G -metric given by

$$G(u, v, w) = \sup_{t \in [0, T]} |u(t) - v(t)| + \sup_{t \in [0, T]} |v(t) - w(t)| + \sup_{t \in [0, T]} |w(t) - u(t)|$$

for all $u, v, w \in X$.

Endow X with the partial order \leq given by: $x, y \in X, x \leq y \Leftrightarrow x(t) \leq y(t)$ for all $t \in [0, T]$. Also, we may adjust as in [25] to prove that (X, G, \leq) is regular.

Theorem 3.1 *Under assumptions (i)-(vi), the system (3.1) has a solution in $X^2 = (C([0, T], \mathbb{R}))^2$.*

Proof Consider the operator $F : X \times X \rightarrow X$ defined by

$$F(x, y)(t) = p(t) + \int_0^T S(t, s)[f(s, x(s)) + k(s, y(s))] ds, \quad t \in [0, T], \text{ for all } x, y \in X.$$

First, we shall prove that F has the mixed monotone property.

In fact, for $x_1 \leq x_2$ and $t \in [0, T]$, we have

$$F(x_2, y)(t) - F(x_1, y)(t) = \int_0^T S(t, s)[f(s, x_2(s)) - f(s, x_1(s))] ds.$$

Taking into account that $x_1(t) \leq x_2(t)$ for all $t \in [0, T]$, so by (iv), $f(s, x_2(s)) \geq f(s, x_1(s))$. Then $F(x_2, y)(t) \geq F(x_1, y)(t)$ for all $t \in [0, T]$, that is,

$$F(x_1, y) \leq F(x_2, y).$$

Similarly, for $y_1 \leq y_2$ and $t \in [0, T]$, we have

$$F(x, y_1)(t) - F(x, y_2)(t) = \int_0^T S(t, s)[k(s, y_1(s)) - k(s, y_2(s))] ds.$$

Having $y_1(t) \leq y_2(t)$, so by (iv), $k(s, y_1(s)) \geq k(s, y_2(s))$. Then $F(x, y_1)(t) \geq F(x, y_2)(t)$ for all $t \in [0, T]$, that is, $F(x, y_1) \geq F(x, y_2)$. Therefore, F has the mixed monotone property.

In what follows, we estimate the quantity $G(F(x, y), F(u, v), F(w, z))$ for all $x, y, u, v, w, z \in X$, with $x \geq u \geq w, y \leq v \leq z$. Since F has the mixed monotone property, we have

$$F(w, z) \leq F(u, v) \leq F(x, y).$$

We obtain

$$\begin{aligned}
 &G(F(x, y), F(u, v), F(w, z)) \\
 &= \sup_{t \in [0, T]} |F(x, y)(t) - F(u, v)(t)| + \sup_{t \in [0, T]} |F(u, v)(t) - F(w, z)(t)| \\
 &\quad + \sup_{t \in [0, T]} |F(w, z)(t) - F(x, y)(t)| \\
 &= \sup_{t \in [0, T]} (F(x, y)(t) - F(u, v)(t)) + \sup_{t \in [0, T]} (F(u, v)(t) - F(w, z)(t)) \\
 &\quad + \sup_{t \in [0, T]} (F(x, y)(t) - F(w, z)(t)).
 \end{aligned}$$

Also, for all $t \in [0, T]$, from (iv), we have

$$\begin{aligned}
 F(x, y) - F(u, v) &= \int_0^T (t, s) [f(s, x(s)) - f(s, u(s))] ds \\
 &\quad + \int_0^T S(t, s) [k(s, y(s)) - k(s, v(s))] ds \\
 &\leq \lambda \int_0^T S(t, s) [\theta(x(s) - u(s)) + \theta(v(s) - y(s))] ds. \tag{3.2}
 \end{aligned}$$

Since the function θ is increasing and $x \geq u \geq w, y \leq v \leq z$, we have

$$\begin{aligned}
 \theta(x(s) - u(s)) &\leq \theta\left(\sup_{t \in I} |x(t) - u(t)|\right), \\
 \theta(v(s) - y(s)) &\leq \theta\left(\sup_{t \in I} |v(t) - y(t)|\right),
 \end{aligned}$$

hence by (3.2), we obtain

$$\begin{aligned}
 &|F(x, y) - F(u, v)| \\
 &\leq \lambda \int_0^T S(t, s) \left[\theta\left(\sup_{t \in I} |x(t) - u(t)|\right) + \theta\left(\sup_{t \in I} |v(t) - y(t)|\right) \right] ds, \tag{3.3}
 \end{aligned}$$

as all the quantities on the right hand side of (3.2) are non-negative, so (3.3) is justified.

Similarly, we can obtain that

$$|F(x, y) - F(w, z)| \leq \lambda \int_0^T S(t, s) \left[\theta\left(\sup_{t \in I} |x(t) - w(t)|\right) + \theta\left(\sup_{t \in I} |z(t) - y(t)|\right) \right] ds, \tag{3.4}$$

$$|F(w, z) - F(u, v)| \leq \lambda \int_0^T S(t, s) \left[\theta\left(\sup_{t \in I} |u(t) - w(t)|\right) + \theta\left(\sup_{t \in I} |z(t) - v(t)|\right) \right] ds. \tag{3.5}$$

Summing (3.3), (3.4) and (3.5), and then taking the supremum with respect to t we get, by using (v), we obtain that

$$\begin{aligned}
 &G(F(x, y), F(u, v), F(w, z)) \\
 &\leq \lambda \sup_{t \in [0, T]} \int_0^T S(t, s) ds \cdot \left[\theta\left(\sup_{t \in I} |x(t) - u(t)|\right) + \theta\left(\sup_{t \in I} |x(t) - w(t)|\right) \right]
 \end{aligned}$$

$$\begin{aligned}
 & + \theta \left(\sup_{t \in I} |u(t) - w(t)| \right) \Big] \\
 & + \lambda \sup_{t \in [0, T]} \int_0^T S(t, s) ds \cdot \left[\theta \left(\sup_{t \in I} |v(t) - y(t)| \right) + \theta \left(\sup_{t \in I} |z(t) - y(t)| \right) \right. \\
 & \left. + \theta \left(\sup_{t \in I} |z(t) - v(t)| \right) \right]. \tag{3.6}
 \end{aligned}$$

Further, since θ is increasing, so we have

$$\begin{aligned}
 \theta \left(\sup_{t \in I} |x(t) - u(t)| \right) & \leq \theta(G(x, u, w)), & \theta \left(\sup_{t \in I} |x(t) - w(t)| \right) & \leq \theta(G(x, u, w)), \\
 \theta \left(\sup_{t \in I} |u(t) - w(t)| \right) & \leq \theta(G(x, u, w)).
 \end{aligned}$$

Similarly, we have

$$\begin{aligned}
 \theta \left(\sup_{t \in I} |v(t) - y(t)| \right) & \leq \theta(G(y, v, z)), & \theta \left(\sup_{t \in I} |z(t) - y(t)| \right) & \leq \theta(G(y, v, z)), \\
 \theta \left(\sup_{t \in I} |z(t) - v(t)| \right) & \leq \theta(G(y, v, z)).
 \end{aligned}$$

Then by (3.6), we have

$$\begin{aligned}
 & G(F(x, y), F(u, v), F(w, z)) \\
 & \leq \lambda \sup_{t \in [0, T]} \int_0^T S(t, s) ds \cdot 3\theta(G(x, u, w)) + \lambda \sup_{t \in [0, T]} \int_0^T S(t, s) ds \cdot 3\theta(G(y, v, z)) \\
 & = 3\lambda \sup_{t \in [0, T]} \int_0^T S(t, s) ds \cdot (\theta(G(x, u, w)) + \theta(G(y, v, z))) \\
 & \leq \frac{(\theta(G(x, u, w)) + \theta(G(y, v, z)))}{2}. \tag{3.7}
 \end{aligned}$$

Since θ is increasing, we have

$$\theta(G(x, u, w)) \leq \theta(G(x, u, w) + G(y, v, z)), \quad \theta(G(y, v, z)) \leq \theta(G(x, u, w) + G(y, v, z))$$

and so

$$\begin{aligned}
 \frac{(\theta(G(x, u, w)) + \theta(G(y, v, z)))}{2} & \leq \theta(G(x, u, w) + G(y, v, z)) \\
 & = \frac{G(x, u, w) + G(y, v, z)}{2} \\
 & \quad - \psi \left(\frac{G(x, u, w) + G(y, v, z)}{2} \right), \tag{3.8}
 \end{aligned}$$

by definition of θ . Thus, by (3.7) and (3.8), we finally get

$$G(F(x, y), F(u, v), F(w, z)) \leq \frac{G(x, u, w) + G(y, v, z)}{2} - \psi \left(\frac{G(x, u, w) + G(y, v, z)}{2} \right)$$

which is just the contractive condition (2.33) in Corollary 2.5.

Let α, β be the functions appearing in assumption (vi), then by (vi), we get

$$\alpha \leq F(\alpha, \beta), \quad \beta \geq F(\beta, \alpha).$$

Applying Corollary 2.5, we deduce the existence of $x, y \in X$ such that

$$x = F(x, y), \quad y = F(y, x),$$

that is, (x, y) is a solution of the system (3.1). □

4 Conclusion

In the frame-work of ordered generalized metric spaces, we established some coupled coincidence and common coupled fixed point theorems for the mixed g -monotone mappings satisfying (ϕ, ψ) -contractive conditions. We accompanied our theoretical results by an applied example and an application to integral equations. Our results are extensions and generalizations of the very recent results of Choudhury *et al.* cited in [10], as well as of several results as in relevant items from the reference section of this paper and in the literature in general.
